Aim of task 1.3 in LIVESEED

- Raise awareness about importance of functioning and up-to-date organic seed databases in the EU
- → Because: Any variety which has **not been registered in the** database shall be considered as unavailable
- Support national authorities in improving system and information quality of their databases
- Reduce administrative burdens for seed supplier to list organic seed in national seed databases (Router database as a backend solution)





Current status on implementation

- All EU Member States provide a "database" according to Art. 48 of EC 889/2008
- Implemented as: online database, Excel or PDF file
- Managed by: national authority or designated body
- Upload of new data by: database manager or seed supplier
- Frequency of updating: real-time, weekly, monthly to annually
- Data collection on granted/rejected derogations: automatically through online database or manually through authority





Additional requirements

- Be informative
- Show actual availability of organic seed supply
- Be user friendly and intuitive to handle
- Reduce administrative burdens for farmer, seed supplier, control bodies and authorities
- Increase the transparency of the organic seed market
- Promote the use of organic seed
- Reduce number of derogations





Features to improve system quality

- Accessibility (direct link to seed database)
- Easy registration process
- Navigability (search/filter for species, seed supplier, etc.)
- Frequent (real-time) updating
- Intuitive user guidance
- History function (what was when available)
- Updating of seed offer (directly by seed supplier)
- Online derogation process (farmer apply online for derogation, authority grants/rejects online)





Features to improve information quality

- Easy language understandable for users (not officialese)
- Process description: how/when to apply for a derogation
- Explanation of national rules (e.g. national implementation of Category I, deadlines for derogation requests, ...)
- Organigram with roles, responsibilities and mandates of stakeholders (authorities, control bodies, seed inspection bodies, expert group)
- User-guides, skilled help-desk, contact for notification
- Additional information (variety traits, breeding process, regional suitability, region of delivery....)





Vision on an EU-wide router database

- Support transparency of available organic seed offers
- Boost the use of organic seed and planting material
- Decrease derogations (as they should be an exception, not the rule)
- Simplify access to international organic seed markets
- Reduce administrative burdens for seed supplier
- Harmonize the use of databases in the EU
- Optional: Give information on breeding process
 - organic breeding, breeding for organic, conventional breeding
- Optional: Give information on critical techniques used in breeding process (e.g. CMS-Hybrids)

Seed supplier shall ensure

- Suitability of offered seed according to pedo-climatic condition
- Offer local supply of seed or supply seed through local trading company

National competent authorities shall ensure

- Fair judgment on seed offers from abroad
- Avoid protectionism
- Reduce trade barriers such as national rules that avoid free flow of commodities





Current status of EU router database

- Programming is almost finalized
- Whole sale level of potential seed supply will be added
- Install interfaces (API) to other national databases
- Testing of database (autumn/winter 2019)
- Translation database and user guides
- Presentation on COP meeting in Oct (planned)
- Official Kick-off: spring 2020
